<b>Fees</b>	<ul style="list-style-type: none"> <li>Invoiced 1 month in advance.</li> <li>Calculated based on booked sessions and use of additional sessions.</li> <li>Invoice sent digitally to nominated email address on or around 25<sup>th</sup> of each month.</li> <li>Reviewed annually, providing you with 1-months' notice of any changes.</li> </ul>	<i>Section 5</i>

<b>Local Authority Funding</b>	<ul style="list-style-type: none"> <li>Please speak to your local nursery leadership who will be happy to provide specific detail on how we offer funded hours, subject to available places.</li> <li>Where your child accesses special, universal or extended funded hours, funding from Local Authorities does not cover provider costs for consumables, meals, additional curricular activities and resources or materials.</li> <li>Government advice to providers is to charge and invoice for these items separately, which Thrive will reference as 'Essential Extras'.</li> <li>Your 'Essential Extras' hourly rate of £1.50 per hour will be added to your monthly private billing.</li> </ul>
